The National Anti-Poverty Organization (NAPO) is a non-profit, non partisan organization that represents the interests of low-income people in Canada. NAPO is registered with Revenue Canada as a charitable organization. Charitable BN 130916638RR0001

The Mandate

NAPO works for the eradication of poverty in Canada by:

- Ensuring the concerns of low-income people are reflected in federal policy and decision making;
- Defending the human and economic rights of low-income people; and,
- Assisting local and regional organizations to bring voices of low-income people in Canada to decision making and policy making processes in their communities.

Issues

The range of issues addressed by NAPO is diverse but includes such topics as:

- social assistance
- unemployment
- federal budget priorities
- human rights
- minimum wages
- youth poverty





What you can do for the future

The most common type of *deferred* planned gift is the **charitable request**. It can be as simples as a sentence or two in your will, or a codicil appended to your present will. Your bequest may specify a certain sum of money: *"I give to NAPO the sum of \$______to be used for its general purposes."*

If you prefer, you may give a particular asset ("*my shares of XYZ stock*") or a portion of the residue of your estate after other bequests have been paid ("50% of the rest, residue and remainder of my estate"). In consultation with NAPO, you may designate a particular purpose for which your bequest is to be used. Your estate will be entitled to a donation receipt for the full value of the bequest, which may reduce significantly the tax payable with your final income tax return.

A gift of life insurance can provide a significant future gift to NAPO at a very modest, present cost to you. You may make such a gift with either an existing policy or a new one.

You may give the death benefit of an existing policy simply by naming NAPO as the beneficiary. However, to receive a current tax benefit, you must also transfer *ownership* of the policy to NAPO which entitles you to a donation receipt for the cash value of the policy. When you make NAPO the owner and beneficiary of a new policy, you receive a donation receipt for every premium you subsequently pay. At your death, NAPO will receive the proceeds.
